

TERMS OF USE

Secret Map

1. Purpose

These Terms of Use (hereinafter referred to as the “Terms”) define the conditions under which users (hereinafter referred to as the “User”) may access and use the Secret Map mobile application (hereinafter referred to as the “Application”), published by Templier Studio, a simplified joint-stock company (SAS) with a share capital of 500 €, registered with the Bayonne Trade and Companies Register under number 989 983 168, whose registered office is located at:

Secret Map is an entertainment application that allows users to map and analyze certain personal experiences in a respectful and non-explicit environment.

The use of the Application implies full and unconditional acceptance of these Terms of Use.

2. Access and conditions of use

2.1 Access to the Application

The Application is intended exclusively for users aged 18 years or older.

The Publisher declines any responsibility in the event of use by a minor.

Access to the Application requires:

a compatible mobile device
an internet connection

2.2 Eligibility

By using the Application, the User declares that they:

have the legal capacity to use the service
are not prohibited from using digital services
will use the Application strictly for personal, lawful and non-commercial purposes

3. Account creation and management

3.1 Registration

Users may register by:

creating an account with a valid email address and password
or using third-party authentication (Google or Apple)

The User chooses a pseudonym.

Additional information may be requested, such as country, preferences or personal experience data related to the use of the Application.

3.2 Security and confidentiality

The User is solely responsible for the confidentiality of their login credentials.

Any activity carried out through the User's account is presumed to have been performed by the User.

If a security breach is suspected, the User must immediately change their credentials and notify the Publisher.

If access to the account is lost, the User may request account recovery or deletion by contacting the Publisher at the same address.

4. Main features

Secret Map allows the User to:

map personal experiences (title, date, location, description, rating)
view personal statistics such as countries mentioned or nationalities encountered
create a "Duo" map allowing experiences to be shared with another user
explore an interactive map without real-time geolocation

The Application is neither a social network nor a dating service.

Information sharing is only possible between users who voluntarily connect using a unique code.

5. User obligations

The User agrees not to publish, transmit or record any content that is:

sexually explicit or pornographic
defamatory, hateful, abusive, racist, homophobic, xenophobic or discriminatory
inciting violence, self-harm or illegal activities

The User also agrees to:

not impersonate another person
not attempt to bypass the security systems of the Application
not attempt to access the data of other users without authorization
respect the principles of consent, privacy and human dignity

The Publisher reserves the right to suspend or delete any account violating these Terms without prior notice or compensation.

A reporting and moderation system is implemented.

6. Intellectual property

All elements of the Application including texts, visuals, logos, design, code and databases are protected by copyright, trademark law and database rights.

Any reproduction, distribution or exploitation of these elements without prior written authorization from the Publisher is strictly prohibited.

Users retain their rights over the personal data they enter.

However, the User grants the Publisher a non-exclusive and free license to use anonymized data for statistical analysis and service improvement purposes.

No personal data is sold to third parties.

7. Liability

The User acknowledges that they use the Application at their own risk.

The Publisher cannot be held responsible for:

the consequences of the use of data entered or consulted within the Application
meetings or relationships resulting from the use of the Application
temporary service interruptions due to maintenance, technical issues or bugs
indirect damages such as loss of data, loss of opportunity or reputational harm

However, the Publisher's liability cannot be entirely excluded and may be engaged in the event of serious breaches of security, confidentiality or legal compliance obligations.

8. Personal data and privacy

The Publisher undertakes to protect personal data in accordance with the General Data Protection Regulation (GDPR).

8.1 Data collected

The Application may collect:

email address or third-party identifier (Google or Apple)
profile data such as pseudonym, country or preferences
internal anonymized statistics

8.2 Legal basis for processing

Some data entered by users may relate to their intimate life and may therefore be considered sensitive data under Article 9 of the GDPR.

Such data is processed only with the explicit consent of the User.

The User may withdraw this consent at any time.

Withdrawal of consent results in the immediate and irreversible deletion of the associated data.

8.3 Data storage

Data is securely stored using Firebase services provided by Google LLC.

Data is hosted in GDPR-compliant data centers located primarily within the European Union.

8.4 User rights

Users may exercise their rights of access, rectification, deletion or data portability at any time by contacting:

A Data Protection Impact Assessment (DPIA) has been conducted in accordance with Article 35 of the GDPR.

9. Duration, suspension and termination

These Terms are concluded for an indefinite period starting from the User's registration.

Users may delete their account at any time through the Application.

In the event of prolonged inactivity, data may be retained for a maximum period of two years before permanent deletion.

Accounts disabled for more than 90 days may be automatically deleted.

The Publisher reserves the right to terminate any account in the event of a clear violation of these Terms.

10. Reporting and legal cooperation

The Publisher commits to:

cooperate with competent authorities
report illegal activities when required by law
block accounts involved in serious violations

11. Modifications of the Terms

The Publisher may modify these Terms at any time.

In the event of significant changes, users will be notified at their next login.

Continued use of the Application constitutes acceptance of the updated Terms.

12. Commercial conditions

The Application is currently free and non-commercial.

If paid features, subscriptions or advertisements are introduced in the future, a dedicated commercial policy will be published within the Application.

13. Governing law

These Terms of Use are governed by French law.

Any dispute relating to the interpretation or execution of these Terms shall be submitted to the competent courts of Bayonne, unless mandatory legal provisions provide otherwise.
