

COMMUNITY GUIDELINES

Secret Map

Secret Map establishes these guidelines in order to ensure a respectful, safe and responsible experience for all users.

These community rules are intended to prevent abuse, protect user privacy and maintain a safe environment within the Application.

By using the Application, users agree to comply with these guidelines.

1. Fundamental principles

Secret Map (hereinafter referred to as the “Application”) is a private and entertainment-focused application with limited social features, including voluntary friend connections and a “duo” profile feature.

The Application is not a social network, not a dating service and not a medical service.

Certain information entered by users may relate to their intimate life and is processed solely on the basis of the user’s explicit consent in accordance with Article 9 of the General Data Protection Regulation (GDPR).

Users may withdraw this consent at any time, which will result in the immediate and permanent deletion of the associated personal data.

Each user agrees to respect the following fundamental values.

- Respect for oneself and others
- Respect for privacy and confidentiality
- Respect for consent and ethical behavior
- Transparency and honesty in declarations
- A responsible, inclusive and non-judgmental approach

2. Strictly prohibited behaviors

The use of the Application is prohibited in the following situations.

- Identity theft or creation of fake profiles
- Use of the Application by minors under the age of 18
- Publication or entry of sexually explicit, pornographic or suggestive content
- Use of the Application for sexual solicitation, commercial promotion, advertising or criminal purposes
- References to illegal practices such as violence, exploitation or non-consensual activities
- Hateful, racist, sexist, homophobic, xenophobic or discriminatory comments
- Threats, intimidation, harassment or pressure directed toward another person
- Unauthorized attempts to access another user's account or data

Attempts to bypass the technical systems of the Application or extract data
Use of inappropriate pseudonyms including offensive, vulgar, explicit or misleading names

Any violation of these rules may result in immediate sanctions as described in Section 8 of these guidelines.

3. Duo feature: specific rules

The creation of a duo map requires:

explicit mutual consent between both users
a double validation of the connection request, with each user confirming independently
the creation of a shared map separate from individual maps
acceptance of partial or full visibility of shared experiences according to the settings defined within the Application

If the duo relationship ends or if one user withdraws their consent, the shared map will be automatically deleted and mutual access revoked.

Creating a duo profile without real consent or by impersonating another person constitutes a serious violation of these guidelines and the Terms of Use.

4. Privacy and confidentiality

User profiles display only limited information.

Pseudonym
Country of origin

The Application does not display photos, personal contact details or real-time geolocation.

Any attempt to capture, share or distribute sensitive information from the Application constitutes a serious violation of these rules.

Experiences entered into the Application are strictly declarative. They are not verified, rated or used for commercial or social purposes.

5. Ethical code: respect and consent

Secret Map is based on an ethical, inclusive and respectful approach.

Consent is absolute and non-negotiable.

Experiences shared in the Application are declarative and anonymous.

No user should be judged or valued based on their history, preferences or number of experiences.

The Application respects and promotes cultural diversity, sexual orientation and gender identity.

The Application does not encourage sexual activity and does not establish any standards or expectations regarding user behavior.

6. Security and protection

Each user commits to protecting their account and personal information.

Login credentials must never be shared, including with a partner.

Users must not leave their device accessible to third parties.

If a user suspects unauthorized use of their account, they must immediately change their password and contact:

The Publisher commits to maintaining a high level of security and confidentiality in accordance with GDPR requirements and applicable data protection standards.

7. Reporting and legal cooperation

Users may report the following issues:

abusive behavior or violations of these guidelines

inappropriate usernames

security vulnerabilities or privacy incidents

In cases involving illegal content or serious violations, Templier Studio may cooperate with competent authorities in accordance with French law.

8. Sanctions

Sanctions are applied depending on the severity of the violation.

Explicit or pornographic content

Immediate account deletion

Identity impersonation

Account suspension and possible legal reporting

Use by a minor

Immediate account deletion without notice

Harassment or hate speech
Account suspension and evidence preservation

Unauthorized sharing of private data
Permanent account ban

Hacking attempts or technical interference
Account deletion and potential legal action

Violation of consent or fake couple profiles
Permanent account deletion and possible legal reporting

9. Acceptance of the guidelines

These Community Guidelines are available at any time within the Application.

By creating an account, users confirm that they have read, understood and accepted these rules.

Continued use of the Application constitutes ongoing acceptance of these guidelines.
